Neighborhood roundup

Beautifying Boston Street

Several members of FSNA have participated in the Boston Street Gateways Task Force which was organized by the Mayor's Office in April. It was formed to focus attention on ways to improve the attractiveness of Boston Street, from the Peabody line to Cooper's Garage at Essex Street, one of the major gateways into Salem. The mayor focused available City of Salem resources on getting the Flynntan site cleaned, designing a more attractive temporary fence at the Flynntan site and do other cleanup projects. The mayor's wife, Mary Usovicz and the mayor's deputy, Tom Philbin, led a tour of Boston Street to review and crystallize ideas that had been discussed.

Martin Imm substituted for Meg Twohey in the walking tour. David Hart also represented the FSNA. Unfortunately, from the FSNA viewpoint, the total focus of the tour was on the Bridge to Peabody section of Boston Street. Martin's report follows:

Mrs. Usovicz had some city resources under her command on the tour and, after additional meeting time of the Boston Street Gateways Task force, expects there will be sufficient City funds available to make some significant improvements during the next year or two. The major City project to be done this year will be to reestablish a large section of missing sidewalks on the West side of Boston Street (on west side, centered on Boston Street Auto body), with associated curbside planting strips and reduced curb cuts. At Flynntan there also will be a low (cheap, because it won't be a long-term fixture) wooden fence installed to replace the chain link, a wildflower mix planted on the upper, open section and a City tree nursery established at the lower, at present, blacktopped section. Unfortunately, these items will use up this year's available City funds, and the Bridge Street-to-Cooper's Garage section will be the focus next year.

Improvements in some other parts of the same sections of Boston Street were discussed and will be advocated by the Task Force and supported by the City. Examples include such things as replacing paved parking strips with tree plantings and grass and/or sea stones. We also learned there are some grants available to commercial property owners on Boston Street to make cosmetic changes of their buildings to improve the aesthetics of this important entrance corridor. This will also be promoted with business owners by Task Force members and supported by the City. It may be possible to focus on the Bridge to Cooper's Garage section of Boston Street with these efforts as well. The volunteer architects on the Task Force had many good ideas that wouldn't cost to much and which could be promoted with business owners to make a difference in how the street would look if carried out.I believe the grant money could be used on the whole of Boston Street.

Coordination of the Task Force's work is being handled by Ellen Dubinsky in City Hall 978-745-9595, ext. 342. She will add any interested parties to her e-mail and mail lists for updates, meeting dates, etc.

The representatives from the various Neighborhood Associations throughout Salem known as the Alliance of Salem Neighborhood Associations, which meets monthly, have become very concerned about the possibility of a Blue Line extension to Salem.

The North Shore Transit Improvement Steering Committee has, for over a year, been studying five alternatives for improvement of transportation on the North Shore. The alternatives are as follows:

1. No action

2. Upgraded and improved commuter rail and bus service

3. Blue Line extension to Lynn/Salem via Commuter Rail Eastern Route

4. Blue Line extension to Lynn/Salem via Narrow Gauge Right-of-Way(3 and 4 distinguish between two possible track routes, both running for the most part parallel to the existMay 2003

ing commuter rail tracks with a terminus at the foot of Mill Hill at Mill and Canal streets.) 5. An intermodal connection between the Commuter Rail and the Blue Line near Wonderland station in Revere.

While the Alliance members are unanimous in their opposition to a Blue Line extension to Salem for obvious reasons — creating a Wonderland North here in our city which is already beseiged with traffic gridlock — it is necessary to have imput from the respective neighborhood groups before taking a public position against a possible Blue Line extension to Salem. (The administration supports this plan and the City Council has voted against it, 9-1.)

Therefore, we ask you as members of the Federal Street Neighborhood Association to report back before June 14 with your position on this important issue which will greatly affect our quality of life here. The FSNA asks that people respond only if they are NOT in agreement with the Alliance position.For more detailled information, go to the project website at:www.mbta.com/projects_underway/nsti.asp

P.S. The two alternatives favored by the Alliance appear to be #2 (improved commuter rail) and #5 (intermodal connection between existing commuter rail and the Blue Line in Revere, allowing for easy access to the airport and downtown Boston). An additional consideration would be having the Blue Line stop at Lynn, where there would be a seamless transfer to the commuter rail.

Witch House reopens

On May 17 the Witch House held a Grand Re-Opening celebration. Admission was waived for all at this special

day-long event that kicked off the 2003 public season at the Witch House. Doug Bollen of the Parks and Recreation department and Kimberly Alexander, architectural historian and consultant, are working with a team of historic house professionals formerly with the Peabody Essex Museum. Nick Carlisle, Jon Markowitz, and Donna Thorland have over a decade of innovative historic house management between them and will reorganize operations at the house.

The team were producers of the Peabody Essex Museum's lately mourned Eerie Events, a theater festival of professionally staged original ghost stories in historic houses. The trio hope to produce a version of the show, which used to attract an audience of 10,000 people over seven nights, for the city this fall. Nick Carlisle is best known for his work with the well-regarded sketch comedy site, tbob.net, and wrote much of the comedic material for Eerie Events. Jon Markowitz has a background in live and recorded music as well as directing, acting, and designing lighting installations. Donna Thorland wrote and directed Eerie Events for six consecutive years of record-breaking profits and attendance.

The Witch House, an excellent example of 17th century architecture, was the home of Judge Jonathan Corwin, and is the only structure still standing in Salem with direct ties to the Witch Trials of 1692. Saved from demolition in 1944 by a group of concerned citizens, the house is owned by Historic Salem and administered by the Department of Parks and Recreation of the City of Salem. It is open May through November.
