Regina Flynn and Tom Philbin are in the process of scheduling a meeting with Salem's new DPW Manager, Brian Thibodeau, and will have our Neighborhood Improvements Committee with him as well. On schedule for this year are the two brick and cobblestone crosswalks one at the top of Federal Street in front of Murphy's Funeral Home and a second just before Federal Court. We will also be working with the City to create a timetable for repairing and replacing the numerous brick sidewalks in our neighborhood. ### **MBTA's North Shore** future to be laid out

On Thursday, February 6, the Draft Environmental Impact Statement (DEIS) on the MBTA's North Shore Transit Improvements Project was discussed. This meeting focused on the Draft EIS as it affects Salem and communities south of Salem. The five alternatives included in the DEIS scope are:

- · No action
- Transportation Systems Management alternatives
- Blue Line extension to Lynn/Salem via the Commuter Rail Eastern Route Main Line.
- Blue Line extension to Lynn/Salem via the Narrow Gauge Right of Way, and
- A connection between the Commuter Rail and Blue Line near Wonderland Station in Revere.

On Wednesday, March 12, a public

meeting on the North Shore Major Investment Study will be held at the Peabody Institute Library of Danvers, 12 Sylvan St., Danvers. MBTA project team members will be available at 6:30 p.m. to discuss the project at an Open House and the Public Meeting will begin at 7 p.m. This meeting will focus on the MIS as it affects Danvers, Peabody, and communities north of Salem.

This meeting will be important to Salem residents because it will be the first opportunity to discuss two recent additions to the MIS: "provide a second track within a new tunnel alignment at Salem" and "implement a 4 1/2-mile commuter rail service between Salem and Danvers passing through Peabody Square (the Danvers branch); service to Boston would join the current commuter rail at Salem. The Danvers service would run to a large new parking facility in Danvers.

## **Edwards-Beckford House, 8 Carpenter Street**

oseph Edwards, a Salem housewright, built this house on land he purchased from Jacob Lord for \$450 in 1808. Edwards worked on the construction of the Custom House on

for the building of the Sheriff's House adjoining the Salem Jail. He occupied the house for less that a year before selling it to Joshua Beckford, a cordwainer, who paid \$1,300 for the land, house and rights to half the well water. When Beckford died in 1833, the estate went to his minor son, Daniel. Daniel's guardian, Sarah P.

Beckford, sold the property at public auction to Jonathan S. Bryant, also a cordwainer. When Bryant died in 1859, he left the house to his brother, Hiram, a shoe manufacturer, who added a two-story addition to the eastern end of the house. Hiram Bryant was the maker of Bryant's Elixir, an elixir to "thrill the blood and banish all the ills that mortal flesh is heir to." He ran his business from the Carpenter Street house until it became to successful that he opened an office in Boston. After Bryant's death in 1883, Jennie Emmerton purchased the house. She made several improvements to it and

merged land she owned on the east end to the lot. She sold the property to another widow, Caroline C. Johnson, in 1904. Philip VonSaltza, a Salem marine artist, lived in the house with his family from 1946 until the late 1970s. The front of this two-and-a-half story Federal-style house faces south with its narrow end to the street. A turn-of-thecentury enclosed entrance porch is centered on its southern elevation. It features fluted pilasters and a dentil course. Another late-19th-century alteration is the two-story, three-sided bay window adjacent to the doorway.
