On Saturday, March 13, 2004, FSNA held it's Annual Meeting at the Grace Church on Essex Street. We congratulated and welcomed our new Ward 2 Councilor Mike Sosnowski to our neighborhood and also thanked Tom Philbin and Regina Flynn for their work and dedication over the past few years. The Federal Street Neighborhood review City Services, City Development, Taxes then voted and approved our new Board for 2004. Stan Szwartz and Mike Williamson will return as Co-Chairs to FSNA, David Hart will continue as the FSNA Treasurer and Pam McKee as our Secretary. The Board for 2004 also includes Jane Arlander, Maggie Lemelin, Rita Markunas, and Will Wrightson. The meeting then moved on to discuss the current issues that we will be reviewing in 2004. In attendance were five of our City Councilors (Mike Bencal, Tom Furey, Kevin Harvey, Mike Sosnowski, and Matt Veno Doug Bollen (Head of Parks and Recreation) was also in attendance and took

the floor to discuss a proposal for installing a dog park at the Leslie's Retreat Park. It was a great discussion and many questions arose. Doug and his group will keep our neighborhood informed of upcoming meetings to continue the process. Rita Markunas was next on the agenda to review and discuss the North River Corridor Master Plan and B6 Zoning Proposal. Her presentation was brilliant and it was clear that our neighborhood will have to continue to work hard to keep the City of Salem on the right track to developing the area along the North River (see roundup below). Our new Ward Councilor Mike Sosnowski then discussed current items under review and thanked us all for our support Mike provided us with an update on the progress of his efforts to have the rail cars removed from the railroad tracks along Bridge Street. Councilor Kevin Harvey, who is the Chair of the Council Finance Committee reviewed the City budget for us, and based on the data, the City will be looking for ways to increase revenues, even with another significant increase in taxes, it appears that several million dollars will need to be cut from next year's budget.

## Neighborhood roundup

FSNA voted to support the North River Canal Corridor Working Group's recommendation that the B6 Zoning proposal be withdrawn from the City Council and Planning Board's consideration. It is crucial that each of us contacts each member of the Salem City Councilors and requests that the B-6 zoning proposal for the North River Corridor be withdrawn or rejected. As you are aware, the B-6 zoning proposal, a "one size fits all" district was never discussed or considered by the Working Group. The Plan document that the Working Group created was to be used as a guideline and that the Working Group wouldconsider zoning review and potential redefinition of each area of the Plan. Once reviewed and approved by the Working Group, a clear zoningregulation would be proposed to fit each area, leaving no margin for confusion among the City or potential Developers. The message is clear: Please contact our City Council and request that they reject any consideration of the proposed B-6 Zoning that has been submitted.
