At the December joint meeting with the Gallows Hill Neighborhood, David Hart provided everyone with an update on the current planning events along the North River/Bridge Street corridor. As we noted last month, there has been some significant disappointment over the progress and achievements the City and Planning Department have accomplished during the past year. As a result, we intend to redistribute our Position Paper and begin the

process of an IPOD (Interim Planning Overlay District). The IPOD would put into place temporary controls which would require that any new development must be consistent with the planning process now taking place.

The Federalist is pleased to report that, since the December meeting, the Working Group

has met twice and has developed a regular schedule of meetings (See box at right.) Also, Regina Flynn has said that the developers of the Osram Sylvania site and the Dept. of Capital Asset Managment will attend an FSNA meeting soon. The Gallows Hill Neighborhood As-

House of the month:

The John Chandler House, 1897, 106 Federal Street

This fine, 2 1/2-story, gambrel roof, Colonial Revival-style house, was inspired by many of Salem's older Federal-style structures. It is attributed to Salem architect Joseph Foster, who also designed 21 Beckford St. for John Chandler. 106 Federal was built in 1897, yet members of the Chandler family had owned the property since the mid-1800s. Joseph Chandler, John's father, ran a store on the first floor of the pre-1897 building and rented out the upstairs. The store not only supplied provisions to the neighborhood, but served as a local

gathering place and center of news and gossip, particularly during the Civil War.

John Chandler became sole owner of 106 Federal St. when his brother died in 1883. Since 1859, John had worked as a clerk in his father's store and later took over the management. In 1874 he moved the business diagonally across the street, to 107 Federal St. and changed his residence from 7 River St. to this new property. The house at 106 Federal became rental property. At his death, Chandler had his estate, which included 106 and 107 Federal

eral, as well as 21 Beckford and 7 River streets, put into a trust for his wife. After Caroline's death, since they had no children, the property was divided between the Association for the Relief of Aged and Destitute Women and the Salem Seaman's Orphan and Children's Friend Society. These organizations sold the property in 1912 to the Wesley Methodist Church, which owned it for 40 years. Since 1952 the house has been in private hands.
